In exercise of the powers conferred by Memorandum of Association rule 4(9) of the Rules and Regulations of Society For Gujarat Dental Health Education and Research (SGDHER), the governing body of SGDHER hereby makes the following rules to provide for regulating recruitment to the post of **Dean**, **Grade I**, in the institutions under the Society for Gujarat Dental Health Education and Research, namely:-

- These rules may be called the Dean, Grade I, in the institutions under the Society for Gujarat Dental Health Education and Research Recruitment Rules, 2020.
- 2. In these rules, unless the context otherwise require;
  - (i) "Equivalent qualification" means the qualification as recognised by the Dental Council of India.
  - (ii) "Appointing Authority" means the Chairman, the Society for Gujarat Dental Health Education and Research.
  - (iii) "Teaching Experience" means teaching experience acquired in Dental College affiliated to a University, established or incorporated by or under the Central or State Act in India acquired in any dental college recognised or approved or permitted by the Dental Council of India only, as the case maybe.
  - (iv) "Dental candidate" means a candidate possessing the degree of Bachelor of Dental Surgery obtained from any of the Universities established in India by law and recognised by Dental Council of India and having registration under the State or Central Law pertaining to and requiring Dental Registration.
  - (v) "Society" means Society for Gujarat Dental Health Education and Research.
- 3. Appointment to the post of Dean, Grade I, in the institutions under the Society shall be made, either, -
  - (a) by promotion of a person who possess 'very good benchmark' for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services classification and recruitment (General) Rules, 1967 from amongst persons, who -
    - (i) have worked for not less than five years in the cadre of Professor, Grade-I, with concerned subjects in the institutions under the Society.

(ii) possess the requisite educational qualification as prescribed in clause (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of Gujarat Civil Services Computer

Competency Training and Examination Rules, 2006. Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause(i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause(i) above;

or

- (b) by direct selection.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall,-

(a) not more than 45 years of age:

- (b) possess Bachelor of. Dental Surgery degree alongwith Master of Dental Surgery recognised by the Dental Council of India in any subject obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Dental Council of India; and
- (c) have at least five years experience on the post not below the rank of Professor, Grade I, in the Dental Colleges or Institutions recognised by the Dental Council of India;
- (d) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules,
- (e) Possess adequate knowledge of Gujarati or Hindi or both.
- 5. The Candidate appointed by direct selection shall be on probation for a period of two years. ,
- 6. The Candidate appointed by direct selection shall, during his/her probation period, require to pass the qualifying examination for computer knowledge in accordance with the provision of the Gujarat Civil Services Competency Training and Examination Rules, 2006.
- 7. The Candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

8. The Candidate appointed by direct selection shall require to get himself registered in a State or Central Dental register under the Dentist Act, 1948, at the time of making an application for direct selection, if he is not so registered.

9. The Candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be

10. The Candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
