In exercise of the powers conferred by Memorandum of Association rule 4(9) of the Rules and Regulations of Society for Gujarat Dental Health Education and Research (SGDHER), the governing body of SGDHER hereby makes the following rules to provide for regulating recruitment to the post of Tutor in Basic Medical Subject and Medical Subject, Grade II, in the institutions under the Society for Gujarat Dental Health Education and Research, namely:-

- 1. These rules may be called the Tutor in basic medical subject and medical subject, Grade II, in the institutions under the Society for Gujarat Dental Health Education and Research Recruitment Rules, 2020.
- 2. In these rules, unless the context otherwise require;
 - (i) "Equivalent qualification" means the qualification as recognised by the Dental Council of India or Medical Council of India, as the case may be.
 - (ii)"Appointing Authority" means the Chairman, the Society for Gujarat Dental Health Education and Research.
 - (iii) "Medical candidate" means a candidate possessing the degree of M.B.B.S obtained from any of the Universities established in India by law and recognised by the Medical Council of India and having registration under the State or Central Law pertaining to and requiring
 - (iv) "Annexure" means Annexure I and Annexure II appended to these
 - (v) "Society" means Society for Gujarat Dental Health Education and Research (SGDHER).
 - 3. Appointment to the post of Tutor in basic medical subject and medical subject, Grade II, in the institutions under the Society for Gujarat Dental Health Education and Research shall be made by direct selection.
 - 4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall,-
 - (a) not be more than 37 years of age:

- (i) academic qualifications as specified respectively against each such posts mentioned in the Annexure I and Annexure II annexed to these rules obtained from any of the Universities established or incorporated by or under the Central or State Act in India, or any other educational institutions recognised as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Dental Council of India or Medical Council of India, as the case may be.
- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (iii) adequate knowledge of Gujarati or Hindi or both.
- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provision of the Gujarat Civil services Competency Training and Examination Rules, 2006.
- 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 8. The candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.
- 9. The candidate appointed by direct selection shall require to get himself registered with a State Medical Council or Indian Medical Council under the Indian Medical Council Act, 1956, at the time of his application for direct selection, if he is not so registered.
- 10. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
