SOCIETY FOR GUJARAT DENTAL HEALTH EDUCATION AND RESEARCH, AHMEDABAD

In exercise of the powers conferred by Memorandum of Association rule 4(9) of the Rules and Regulations of Society for Gujarat Dental Health Education and Research (SGDHER), the governing body of SGDHER hereby makes the following rules to provide for regulating recruitment to the post of Associate Professor, Grade I, in the Dental Subjects mentioned in the Annexure in the institutions under the Society for Gujarat Dental Health Education and Research, namely:-

- 1. These rules may be called the Associate Professor, Grade I, in the dental subjects mentioned in the Annexure at the institutions under the Society for Gujarat Dental Health Education and Research Recruitment Rules, 2020.
- 2. In these rules, unless the context otherwise requires;
 - (i) "Dental Candidate" means a candidate possessing the degree of Bachelor of Dental Surgery obtained from any of the Universities established in India by law and recognized by Dental Council of India and having registration under the State or Central Law pertaining to and requiring Dental Registration.
 - (ii) "Annexure" means the annexure appended to these rules.
 - (iii) "Society" means Society for Gujarat Dental Health Education and Research (SGDHER).
- 3. Appointment to the post of the Associate Professor, Grade I, in the dental subjects mentioned in the annexure at the institutions under the Society shall be made either, -
 - (a) by promotion of a person who possess 'very good benchmark' for being considered fit for promotion as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who, -
 - (i) have worked for not less than five years in the cadre of Assistant Professor, Grade-I, in concerned subject mentioned in the Annexure at the institutions under the Society;

- (ii) possess the educational qualification as prescribed in sub clause (i) of clause (b) of rule 4 for direct selection; and
- (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006;

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause(i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause(i) above;

or

- (b) by direct selection.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 3, the candidate shall,-
 - (a) not be more than 42 years of age:
 - (b) possess, -

academic qualifications as specified respectively against each subject in the Annexure obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institutions recognized as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Dental Council of India;

- (c) have about Four years teaching experience in the concerned subject as specified in Annexure on the post not below the rank of Tutor Grade-II in the Dental Colleges recognized by the Government and Dental Council of India after acquiring the post graduate degree i.e. Master of Dental Surgery;
- (d) basic knowledge of computer application as prescribed by the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (e) adequate knowledge of Gujarati or Hindi or both.

- The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 8. The candidate appointed by direct selection shall require to get him registered with the State or Central Dental Council under the Dental Council Act, 1948 at the time of his application for direct selection, if he is not so registered.
- The candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
- 10. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
